

**MAURY COUNTY DEMOCRATIC PARTY  
2026 NOMINATING CONVENTION RULES**

The rules for the 2026 Maury County Democratic Party Nominating Convention (“caucus”) shall be as follows:

**I. PURPOSE AND SCOPE**

1. The purpose of this caucus is to nominate Democratic Party candidates for County offices, in accordance with Tennessee state law, including these offices:
  - a. Maury County Executive (also known as County Mayor)
  - b. Maury County Commission (two Commissioners in each of the eleven (11) districts).
  - c. Maury County Public Schools Board (one school board member in each of the odd-numbered districts, plus any special elections required).
  - d. Maury County Sheriff, Trustee, Register of Deeds and County Clerk.
  - e. Maury County Constable (one in each of the eleven (11) districts).
2. The Caucus **shall not** nominate or endorse candidates for:
  - a. Federal office.
  - b. State office.
  - c. Local (municipal) offices in the Cities of Columbia, Spring Hill, or Mt. Pleasant.
3. Additionally, the caucus **may**:
  - a. Grant Independent candidates the right to briefly introduce themselves, or solicit petition signatures or donations, so long as a Democrat is not running for the same seat (in County Commission races, this rule shall be construed to allow Independent candidates to speak so long as there are not at least two Democrats running for the same seat).
  - b. Grant candidates seeking the Democratic nomination for federal, state, or local offices the opportunity to briefly introduce themselves.
  - c. Provide general information on the Maury County Democratic Party (or Tennessee Democratic Party, or affiliated organizations such as the Maury County Democratic Women) to attendees, including information about upcoming events and opportunities to get engaged or involved.
4. The caucus shall not be construed as a meeting of the Maury County Democratic Party’s County Executive Committee. The County Executive Committee may hold an emergency meeting after the conclusion of the caucus to deal with urgent business as permitted by the Bylaws. Such a meeting must be called by the Chair at least three days in advance per Article VI of the Bylaws.

## **II. TIME AND DATE**

1. The caucus shall be held on February 28, 2026, starting at 1 p.m. and concluding no later than 4 p.m., at a suitable venue. Doors will open one hour prior to the start time (noon).
2. The Chair may schedule a makeup date in the event of inclement weather or other unforeseeable situations which would make the date scheduled above impractical.

## **III. ELIGIBILITY TO PARTICIPATE**

1. All *bona fide* Democrats who are lawfully registered to vote prior to February 1, 2026, and who reside in Maury County, are eligible to participate in this Caucus.
2. A *bona fide* Democrat shall include all Democrats, including, at a minimum:
  - a. All people registered to vote in Maury County (see above) who voted in the Tennessee Democratic Party primary in August 2024;
  - b. All people registered to vote in Maury County, who voted in the Tennessee Democratic Party presidential preference primary in March 2024, and who did not subsequently participate in the Republican Party primary in August 2024;
  - c. All people registered to vote in Maury County, who have voted in at least three of the five previous Tennessee Democratic Party primaries and presidential preference primaries (in August 2024, March 2024, August 2022, August 2020, or March 2020); and
  - d. All other persons registered to vote in Maury County, who are determined to be *bona fide* Democrats by being “vouched for” by at least one member of the Credentials Committee.
3. The NGP VoteBuilder website (provided by the TNDP) shall be used, and data from it shall be deemed conclusive evidence, regarding voter residence, registration, and voting record.
4. Participants must be in line no later than the start time listed in Article II above. Doors will be closed at this time. A member of the Credentials Committee shall ensure that no additional participants are permitted to enter after that time.
5. Attendees who are ineligible shall be allowed to watch the caucus as guests of the Maury County Democratic Party but shall not otherwise be allowed to participate. The Sergeant at Arms and the Chair may remove attendees if they are disruptive.

#### **IV. ELIGIBILITY TO BE NOMINATED AS A CANDIDATE**

1. To be nominated as a candidate, a person must:
  - a. Be eligible to participate in the caucus, and meet all the criteria set forth above;
  - b. Declare their desire, in writing to the Chair or Secretary, to pursue the Maury County Democratic Party's nomination, no later than five business days prior to the beginning of the caucus (i.e. Sunday, February 22, 2026, for a caucus to be held on Saturday, February 28, 2026);
  - c. Demonstrate, either by producing documents or by credibly asserting in writing, to the satisfaction of the Vetting Committee, that they are lawfully qualified to hold the office they are seeking, including any special legal requirements of the office (for example, school board candidates must reside in the district they are running in, and possess a high school diploma); and,
  - d. Be of good moral character, as determined by the caucus participants.
2. Additional candidates shall not be put forth "from the floor" on the day of the caucus, or in any committee. The intent of this rule is to prevent circumvention of the vetting process.
3. The Vetting Committee may ask candidates to affirm that they will support the eventual party nominees.

## **V. ORDER OF BUSINESS**

The order of business of the caucus shall be as follows:

1. Call to Order
2. Pledge of Allegiance
3. Invocation (if requested)
4. Welcoming Remarks by the Chair
5. Guest Speakers (if any; this shall be at the discretion of the Chair)
6. Report of the Credentials Committee
7. Report of the Vetting Committee
8. Consideration of Nominations for Countywide Offices (Mayor, Sheriff, Clerk, Trustee, Register of Deeds)
9. Break into District Committees, which shall be asked to make recommendations for nominations of district-level candidates (County Commission, School Board, Constable)
10. Consideration of District Committees' recommendations (to nominate candidates for County Commission, School Board, Constable)
11. Concluding Remarks
12. Adjournment

## **VI. METHOD OF VOTING; CANDIDATE SPEECHES**

1. Before a vote is held, each candidate shall be allowed to speak for up to two (2) minutes.
2. The Chair (or District Committee Chair) may allow up to five (5) minutes per office for participants to ask the candidates questions, and an additional five (5) minutes of discussion about the candidates per office sought.
3. All nominations, motions, and other business shall be determined by a public vote (either by voice vote, "show of hands," or division of the body), as required by our Bylaws. Paper ballots shall not be used, because they are not permitted by our Bylaws.
4. Proxy voting, unit rule, etc. shall not be used, according to our Bylaws.
5. "None of the Above" shall be included as an option for all nomination votes.
6. Majority voting shall be used to select nominees (and recommendations in the District Committees). Voting shall continue until one candidate (or "None of the Above") receives a majority of the votes cast. Each round of voting shall include the candidates (or "None") from the previous round, except for the candidate (or "None") with the fewest votes.
7. In the case of County Commission, a District Committee shall consider each of the two County Commission seats separately (seat "A" and seat "B"). If a candidate wins the District Committee's recommendation for Seat "A," all the other candidates (and "None of the Above") shall be valid options when Seat "B" is voted upon. If "None of the Above" wins for Seat "A" (or if no other candidates remain), Seat "B" shall not be considered.
8. The Chair shall abstain from all votes except in the event of a tie, in which case the Chair shall break the tie.
9. The Chair shall appoint at least two volunteer assistant counters to help count votes.

## **VII. CREDENTIALS COMMITTEE**

1. The purpose of the Credentials Committee is to ensure that participation is limited to *bona fide* Democrats and to resolved disputes about who is eligible to participate.
2. The Chair shall appoint the Credentials Committee at least seven (7) days prior to the caucus, and it shall consist of at least five (5) *bona fide* Democrats, including the Chair.
3. The Credentials Committee shall verify the residence and voter registration status of participants using VoteBuilder, or printed reports generated using VoteBuilder data. Additional identification documents (driver's license, etc.) may be examined if one or more members of the Credentials Committee request proof of a person's identity.
4. The Credentials Committee shall prepare a report, not later than 2 p.m., of all eligible participants who are eligible under these rules. The report shall state:
  - a. The total number of participants who are eligible to participate, and the number of eligible participants per district.
  - b. The total number of attendees who were deemed ineligible to participate.
  - c. The names and county commission districts of all attendees, as well as whether they were deemed eligible to participate based upon voting record, or vouched for, or deemed ineligible (and the reason they were deemed ineligible).
5. The Credentials Committee shall verbally present its report to the caucus attendees, stating:
  - a. The total number of eligible participants, as well as the number of eligible participants per district.
  - b. The number of attendees ineligible to participate, and the names of those deemed ineligible. The full list of eligible participants need not be read but may be referred to if necessary to clarify anyone's eligibility status.
6. The caucus participants who are deemed eligible to participate in the Credentials Committee report, and whose *bona fides* are not otherwise in dispute, may then debate the report and amend it as necessary before adopting it.
7. The committee may use online registration forms to collect information prior to the caucus.
8. All candidates vetted by and receiving a favorable or neutral recommendation from the Vetting Committee (see below), shall automatically be deemed eligible to participate in the caucus by the Credentials Committee. This rule is to prevent conflict between the committees and to reduce unnecessary duplication of effort.

## **VIII. VETTING COMMITTEE**

1. The purpose of the Vetting Committee is to perform basic due diligence.
2. The Chair shall appoint the Vetting Committee at least seven (7) days prior to the caucus, and it shall consist of five (5) *bona fide* Democrats, including the Chair.
3. The Vetting Committee shall:
  - a. Receive all candidate declarations from the Chair or Secretary (see above).
  - b. Verify that candidates are eligible to participate in the caucus, using the same methods and criteria used by the Credentials Committee.
  - c. Verify the district and county residence of each candidate, as necessary, using VoteBuilder or any other facts known to members of the committee.
  - d. Obtain criminal background checks, as practical, for candidates, as well as search public indexes and registries (such as the Tennessee Sex Offender Registry).
  - e. Verify, to a reasonable degree of certainty, that candidates are legally qualified to hold the office they are pursuing.
  - f. Meet before the caucus doors open to confidentially discuss the items above for each candidate, and produce a report giving a favorable, unfavorable, or neutral recommendation for each candidate.
    - i. The committee should generally give qualified and morally-sound candidates a favorable recommendation, regardless of other biases.
    - ii. The committee shall give candidates who are legally unqualified, not a resident of Maury County or in the district they are running in, not *bona fide* Democrats, or who have serious criminal records an unfavorable recommendation.
  - g. Present its report on the day of the caucus, stating only the name of each candidate, the office each candidate is seeking, and its recommendation (favorable, unfavorable, or neutral) for each candidate.
  - h. If requested by a candidate, or the chair of any District Committee, a representative of the Vetting Committee shall state the reasons for the committee's recommendation.
  - i. The eligible participants of the caucus shall vote to approve, or amend, the Vetting Committee report.

## **IX. DISTRICT COMMITTEES**

1. The purpose of the District Committees shall be to recommend a slate of candidates for the caucus body to nominate for each district (up to two candidates for County Commission, one candidate for School Board, and one candidate for Constable).
2. Caucus participants from each of the eleven (11) County Commission districts in Maury County shall be members of their respective District Committee.
3. Each District Committee shall select its own Committee Chair and (if there are more than two (2) members of the District Committee) elect a Secretary.
4. The Credentials Committee shall provide a list of eligible participants in each district to the District Committees.
5. The Vetting Committee shall provide each District Committee with a list of candidates running in the district, and the committee's recommendation (favorable, unfavorable, neutral) for each.
6. The District Committee may allow speeches, questions, and discussion as provided in the "Method of Voting" article (Article VI) above.
7. The District Committee shall vote to select its recommended slate of nominees for each office (and two for county commission). Each office shall be considered separately:
  - a. County Commission Seat "A."
  - b. County Commission Seat "B."
  - c. School Board
  - d. Constable
8. The Chair of each District Committee shall present a report stating its recommended slate of candidates.
9. All eligible caucus participants shall approve or amend the slate reported by each District Committee. The caucus body may only amend a slate by replacing a candidate recommended by a District Committee with "None of the Above;" it may not substitute another candidate previously rejected by the District Committee.



**X. DUTIES OF PARTY OFFICERS**

1. The Chair shall call the meeting to order, appoint committee members (except for the District Committees), appoint a Sergeant at Arms, and otherwise maintain order.
2. The Chair shall remain neutral in all votes unless it is necessary to break a tie, except that the Chair may vote in the Vetting and Credentials committees.
3. If the Chair is a candidate, a Vice Chair shall preside over the vote for the office that the Chair is running for.
4. The Secretary shall keep minutes of the Caucus, as well as collect minutes and notes from each of the committees (including District Committees).
5. The Chair and Secretary shall report the results of the caucus to the Maury County Elections Commission in an appropriate letter as required by state law, no later than the filing deadline (March 10, 2026, at noon).
6. The Chair, Secretary, and Communications Committee shall work to publicize the caucus as well as the results.
7. The whole Executive Committee shall work to recruit candidates, encourage caucus participation, and set expectations with them.

**XI. RULES WHERE NOT OTHERWISE SPECIFIED HEREIN**

Roberts Rules of Order, Newly Revised, 12<sup>th</sup> Edition, shall be used by the Chair to resolve any disputes not addressed by these rules.

**XII. GENERAL RULE OF CONSTRUCTION; DISCRIMINATION PROHIBITED**

In all cases, these rules shall be construed to conform with the Bylaws of the Maury County Democratic Party, the Bylaws of the Tennessee Democratic Party, and the general laws of the State of Tennessee and of the United States of America.

The Maury County Democratic Party shall not discriminate against caucus attendees based on sex, race, age, color, creed, national origin, religion, economic status, gender, sexual orientation, gender identity, ethnic origin, identity, or disability.

## **VOTING EXAMPLES**

### **Example 1: School Board with One Candidate Seeking Nomination**

#### *Round 1 Options*

CANDIDATE A

NONE OF THE ABOVE

The winner of Round 1 shall be the winner and shall be reported as part of a district's recommended slate.

### **Example 2. County Commission with One Candidate Seeking Nomination**

#### *Seat "A," Round One*

CANDIDATE A

NONE OF THE ABOVE

The winner shall be reported as part of a district's recommended slate. Seat "B" will not be considered, either because "NONE OF THE ABOVE" won, or because CANDIDATE A won, and there are no remaining candidates to consider.

### **Example 3. County Commission with Two Candidates Seeking Nomination**

#### *Seat "A," Round One*

CANDIDATE A

CANDIDATE B

NONE OF THE ABOVE

If Candidates "A" or "B" win, the winner shall be reported as part of a district's recommended slate, and the other candidate shall be considered for Seat "B."

If "None of the Above" wins for Seat "A," voting shall cease; there is no point to voting on Seat "B."

Assume Candidate "A" wins Seat "A," then:

#### *Seat "B," Round One*

CANDIDATE B

NONE OF THE ABOVE.

The winner shall be reported as part of the district's slate. The final slate could therefore consist of "A," "B," both "A" and "B," or neither "A" nor "B."

#### **Example 4. County Mayor with Three Candidates Seeking Nomination**

##### *Round One*

CANDIDATE A

CANDIDATE B

CANDIDATE C

NONE OF THE ABOVE.

If any candidate (including “NONE OF THE ABOVE”) receives a majority, voting shall cease and the winner shall be nominated.

If no candidate receives a majority, the candidate with the fewest votes shall be dropped and a second round will be held. Assume Candidate C receives the fewest votes; he will be eliminated and the second round shall commence:

##### *Round Two*

CANDIDATE A

CANDIDATE B

NONE OF THE ABOVE

Assume “NONE OF THE ABOVE” receives the fewest votes in Round Two:

##### *Round Three*

CANDIDATE A

CANDIDATE B

The winner of this round shall be nominated.

If at any point “NONE OF THE ABOVE” receives a majority, voting shall cease.
